THE UNDERSIGNED, each with the capacity to contract, hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation not for profit under and by virtue of the laws of the State of Virginia, Pursuant to Chapter 10 of Title 13.1 of the Code of Virginia; the undersigned corporation submits the following information:

### **Article 1 Name And Address**

The name of this corporation shall be New City Network, Inc.

#### **Article 2 Shares**

This is a non-stock corporation and is not authorized to issue stock.

# **Article 3 Purpose**

The specific purpose for which the corporation is initially organized to be a integrated auxiliary of McLean Bible Church, Inc., to provide administrative and spiritual oversight and direction for other organizations which will themselves be organized and operated exclusively for educational, charitable, and/or religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 and shall voluntarily be partnered with this organization and to also engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith which are consistent with Section 501(c)(3) of the Internal Revenue Code. This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3), Internal Revenue Code.

# **Article 4 Qualifications Of Members**

This corporation shall have members. The eligibility, rights and obligations of the members will be determined by the organization's bylaws.

# **Article 5 Term And Dissolution**

The date of commencement of corporate existence shall be when these articles have been filed with the Commission and approved by it and the respective filing fee has been paid; the term for which the corporation is to exist shall be perpetual.

In the event of dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

# **Article 6 Non Profit Corporation**

This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3), Internal Revenue Code.

No part of the net earnings of the corporation shall ever inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3. No substantial part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal Income Tax under Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law or: (b) by a corporation, contributions to which are deductible under Section 170(C) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue laws.

# **Article 7 Initial Registered Office And Agent**

The street address of the corporation's Initial Registered Office, located in the county of Fairfax, is:

The name of its Initial Registered Agent at that office is William H. Steele, a resident of Virginia.

The Initial Registered Agent is an initial director of the corporation.

The initial registered office address of the corporation is identical to the business office of the initial registered agent.

#### **Article 8 Directors**

The Board of Directors of the corporation shall consist of no less than three (3) directors as determined by the Bylaws. Directors shall be appointed annually by the Directors.

The Board of Directors shall have the authority to make provision for reasonable compensation to its members for their services as directors and to fix the basis and conditions upon which this compensation shall be paid. Any director may also serve the corporation in any other capacity and receive compensation therefrom in any form.

# **Preamble**

BE IT RESOLVED, that we recognize ourselves as a body of Christian believers working together for the common purpose of spreading the Gospel of our Lord and Savior Jesus Christ, and that under the laws of the State of Virginia we may exercise all the rights and privileges granted to religious bodies.

# **Article II Purpose**

#### Man

Man is the special creation of God, made in His own image. He created them male and female as the crowning work of His creation. The gift of gender is thus part of the goodness of God's creation. Through the temptation of Satan man transgressed the command of God, and fell from his original innocence whereby his posterity inherit a nature and an environment inclined toward sin. #### **Salvation**

Salvation involves the redemption of the whole man, and is offered freely to all who accept Jesus Christ as Lord and Saviour, who by His own blood obtained eternal redemption for the believer. In its broadest sense salvation includes regeneration, justification, sanctification, and glorification. There is no salvation apart from personal faith in Jesus Christ as Lord.

A. Regeneration, or the new birth, is a work of God's grace whereby believers become new creatures in Christ Jesus. It is a change of heart wrought by the Holy Spirit through conviction of sin, to which the sinner responds in repentance toward God and faith in the Lord Jesus Christ. Repentance and faith are inseparable experiences of grace.

Repentance is a genuine turning from sin toward God. Faith is the acceptance of Jesus Christ and commitment of the entire personality to Him as Lord and Saviour.

B. Justification is God's gracious and full acquittal upon principles of His righteousness of all sinners who repent and believe in Christ. Justification brings the believer unto a relationship of peace and favor with God.

C. Sanctification is the experience, beginning in regeneration, by which the believer is set apart to God's purposes, and is enabled to progress toward moral and spiritual maturity through the presence and power of the Holy Spirit dwelling in him. Growth in grace should continue throughout the regenerate person's life.

D. Glorification is the culmination of salvation and is the final blessed and abiding state of the redeemed.

#### **God's Purpose of Grace**

Election is the gracious purpose of God, according to which He regenerates, justifies, sanctifies, and glorifies sinners. It is consistent with the free agency of man, and comprehends all the means in connection with the end. It is the glorious display of God's sovereign goodness, and is infinitely wise, holy, and unchangeable. It excludes boasting and promotes humility.

All true believers endure to the end. Those whom God has accepted in Christ, and sanctified by His Spirit, will never fall away from the state of grace, but shall persevere to the end.

Believers may fall into sin through neglect and temptation, whereby they grieve the Spirit, impair their graces and comforts, and bring reproach on the cause of Christ and temporal judgments on themselves; yet they shall be kept by the power of God through faith unto salvation.

#### The Church

#### Baptism and the Lord's Supper

Christian baptism is the immersion of a believer in water in the name of the Father, the Son, and the Holy Spirit. It is an act of obedience symbolizing the believer's faith in a crucified, buried, and risen Saviour, the believer's death to sin, the burial of the old life, and the resurrection to walk in newness of life in Christ Jesus. It is a testimony to his faith in the final resurrection of the dead. Being a church ordinance, it is prerequisite to the privileges of church membership and to the Lord's Supper.

The Lord's Supper is a symbolic act of obedience whereby members of the church, through partaking of the bread and the fruit of the vine, memorialize the death of the Redeemer and anticipate His second coming.

#### **Education**

Christianity is the faith of enlightenment and intelligence. In Jesus Christ abide all the treasures of wisdom and knowledge. All sound learning is, therefore, a part of our Christian heritage. The new birth opens all human faculties and creates a thirst for knowledge. Moreover, the cause of education in the Kingdom of Christ is co-ordinate with the causes of missions and general benevolence, and should receive along with these the liberal support of the churches. An adequate system of Christian education is necessary to a complete spiritual program for Christ's people.

In Christian education there should be a proper balance between academic freedom and academic responsibility. Freedom in any orderly relationship of human life is always limited and never absolute. The freedom of a teacher in a Christian school, college, or seminary is limited by the pre-eminence of Jesus Christ, by the authoritative nature of the Scriptures, and by the distinct purpose for which the school exists.

# Stewardship

According to the Scriptures, Christians should contribute of their means cheerfully, regularly, systematically, proportionately, and liberally for the advancement of the Redeemer's cause on earth.

#### **Cooperation**

Christ's people should, as occasion requires, organize such associations and conventions as may best secure cooperation for the great objects of the Kingdom of God. They are voluntary and advisory bodies designed to elicit, combine, and direct the energies of our people in the most effective manner. Members of New Testament churches should cooperate with one another in carrying forward the missionary, educational, and benevolent ministries for the extension of Christ's Kingdom. Christian unity in the New Testament sense is spiritual harmony and voluntary cooperation for common ends by various groups of Christ's people. Cooperation is desirable between the various Christian denominations, when the end to be attained is itself justified, and when such cooperation involves no violation of conscience or compromise of loyalty to Christ and His Word as revealed in the New Testament.

We should speak on behalf of the unborn and contend for the sanctity of all human life from conception to natural death. Every Christian should seek to bring industry, government, and society as a whole under the sway of the principles of righteousness, truth, and brotherly love. In order to promote these ends Christians should be ready to work with all men of good will in any good cause, always being careful to act in the spirit of love without compromising their loyalty to Christ and His truth.

#### **Religious Liberty**

God alone is Lord of the conscience, and He has left it free from the doctrines and commandments of men which are contrary to His Word or not contained in it. Church and state should be separate. The state owes to every church protection and full freedom in the pursuit of its spiritual ends. In providing for such freedom no ecclesiastical group or denomination should be favored by the state more than others. Civil government being ordained of God, it is the duty of Christians to render loyal obedience thereto in all things not contrary to the revealed will of God. The church should not resort to the civil power to carry on its work. The gospel of Christ contemplates spiritual means alone for the pursuit of its ends. The state has no right to impose penalties for religious opinions of any kind. The state has no right to impose taxes for the support of any form of religion. A free church in a free state is the Christian ideal, and this implies the right of free and unhindered access to God on the part of all men, and the right to form and propagate opinions in the sphere of religion without interference by the civil power.

# The Family

A husband is to love his wife as Christ loved the church. He has the God-given responsibility to provide for, to protect, and to lead his family. A wife is to submit herself graciously to the servant leadership of her husband even as the church willingly submits to the headship of Christ. She, being in the image of God as is her husband and thus equal to him, has the God-given responsibility to respect her husband and to serve as his helper in managing the household and nurturing the next generation.

Children, from the moment of conception, are a blessing and heritage from the Lord. Parents are to demonstrate to their children God's pattern for marriage. Parents are to teach their children spiritual and moral values and to lead them, through consistent lifestyle example and loving discipline, to make choices based on biblical truth. # **Article IV Affiliation - Integrated Auxiliary**

The official affiliation of this ministry is with McLean Bible Church, located in Vienna, Virginia. There is an institutional relationship between New City Network, Inc. and McLean Bible Church because the Corporation is an outreach of McLean Bible Church

#### Terms of Affiliation

The terms of affiliation shall be as follows:

- 1. The President of this ministry shall:
  - A. be subject to the leadership and guidance of the McLean Bible Church
  - B. ardently adhere to and teach the doctrines and tenets as set forth by McLean Bible Church.
  - C. uphold and defend McLean Bible Church and its Board of Elders.
- 2. This ministry shall:
  - A. be subject to the leadership and guidance of the McLean Bible Church
  - B. ardently adhere to and teach the doctrines and tenets as set forth by McLean Bible Church
  - C. uphold and defend McLean Bible Church and its Board of Elders.
  - D. irrevocably keep affiliation with the McLean Bible Church
  - E. have assets that may not be transferred, sold, conveyed or disposed of, without the written consent of McLean Bible Church
  - F. maintain and control its assets in its own name.
  - G. upon dissolution, have all of the assets of this church turned over to the ownership of McLean Bible Church

- H. not have dissolution enacted unless written permission from McLean Bible Church has been granted.
- I. give McLean Bible Church a monthly report of income and expenses as well as a balance sheet of all assets and liabilities.

# **Article V Affiliate Churches - Membership**

This organization may also have member churches. The voting rights and privileges of member churches shall be prescribed through corporate resolutions. Any rights or privileges shall be published in the Affiliate Church Program.

#### Article VI Government

#### Section 1 Board of Directors

- 1. There shall be a President.
- 2. There may be a Vice President.
- 3. There shall be a Secretary.
- 4. There shall be a Treasurer.
- 5. Other individuals shall be added as needed.

### **Section 2 Official Board and Voting Power**

- 1. The Board of Directors is that group of persons vested with the management of the business and affairs of the corporation.
- 2. The official Board of Directors shall consist of individuals listed above and those added by official action of the Board of Directors.
- 3. The majority shall serve without remuneration and not be related by blood or marriage.
- 4. The President shall be chairman of the board and chief executive of the corporation.
- 5. Each member of the board shall have equal voting power among all of the other members.
- 6. A decision of the Board of Directors is considered valid with a simple majority vote, unless otherwise specified in the Bylaws.
- 7. The President shall be an ex officio member of every committee and can at his discretion be the chair of such committee at the time of its creation.

#### Section 3 Removal From the Board of Directors

Any Board of Directors member may be removed from office with or without cause by a simple majority vote of the Board of Elders of McLean Bible Church

#### Section 4 Process for Removal From the Board of Directors

A Board of Directors member may be removed from the board in the following manner:

- 1. By letter of resignation submitted to the President;
- 2. By action of the Board of Elders of McLean Bible Church

#### **Article VII Official Functions**

# **Section 1 President Qualifications**

The President shall have wisdom in handling the corporation's affairs. He shall be of sound doctrine and good judgment.

#### **Duties**

The President shall be the leader of the ministry as provided by the Holy Scriptures.

The President shall be chairman of the official Board of Directors and preside over all corporation meetings.

#### **Term of Office**

The term of office of the President shall be reviewed every two years. The number of consecutive terms that he may serve is unlimited.

#### Section 2 President Successor

The President may nominate a successor at any time. The nominee shall be confirmed by simple majority vote of the Board of Elders of McLean Bible Church, after the nomination is made. This person will assume the role of the President if the President retires, passes away unexpectedly or is otherwise incapacitated.

#### No successor appointed

Should the President fail to appoint a successor, the Board of Elders of McLean Bible Church shall appoint a qualified individual by simple majority vote.

# Section 3 Vice President Qualifications

The Vice President shall have wisdom in handling the corporation's affairs. He shall be of sound doctrine and good judgment.

#### **Duties**

He will serve as chief advisor to the President.

He shall carry out the responsibilities that the President delegates to him.

#### **Manner of Appointment**

The President shall nominate and the Board of Elders of McLean Bible Church shall confirm the Vice President to office by a simple majority vote.

#### **Term of Office**

The term of office of the Vice President shall be reviewed every two years. The number of consecutive terms that he may serve is unlimited. He is subject to removal at any time in accordance with Article V.

# **Section 3 Secretary Qualifications**

The Secretary shall be a spiritually minded person and of sound judgment. He must be administratively minded with the ability to multi-task.

#### **Duties**

By virtue of his office, the Secretary shall keep a true and accurate record of all meetings, including business meetings of the corporation. He shall perform clerical duties, and shall be the custodian of all legal documents.

#### **Manner of Appointment**

The President shall nominate and the Board of Elders of McLean Bible Church shall confirm the Secretary to office by a simple majority vote.

#### **Term of Office**

The term of office of the Secretary shall be reviewed every two years. The number of consecutive terms that he may serve is unlimited. He is subject to removal at any time in accordance with Article V.

# Section 4 Treasurer **Qualifications**

The Treasurer shall be a spiritually minded person, and of sound business judgment. He shall be capable of doing the accounting required to maintain the corporation books.

#### **Duties**

By virtue of his office, the Treasurer shall keep, in a business-like manner, an itemized account of all receipts and disbursements of moneys committed to his trust and shall make reports to be presented during the official Board of Elders meetings. He shall deposit and make withdrawals in a manner prescribed in Article XVI.

#### **Manner of Appointment**

The President shall nominate and the Board of Elders of McLean Bible Church shall confirm the Treasurer to office by a simple majority vote.

#### **Term of Office**

The term of office of the Treasurer shall be reviewed every two years. The number of consecutive terms that he may serve is unlimited. He is subject to removal at any time in accordance with Article V.

# **Section 5 Directors Qualifications**

Directors shall be spiritually minded persons, and of sound business judgment.

#### **Duties**

By virtue of their office, Directors shall carry out the responsibilities that the President or Board of Directors delegate to them.

#### **Manner of Appointment**

The President shall nominate and the Board of Elders of McLean Bible Church shall confirm Directors to office by a simple majority vote.

#### **Term of Office**

The term of office of the Directors shall be reviewed every two years. The number of consecutive terms that a Director may serve is unlimited. Directors are subject to removal at any time in accordance with Article V.

# **Article VIII Meetings**

### **Section 1 Corporation Meetings**

The corporation year shall coincide with the calendar year beginning on January 1st, and running through December 31st.

The President will call the official Board of Directors meeting to discuss the direction of the corporation. The President shall set dates and times for Board of Directors meetings. The Board of Directors may have invited guests present at any meeting so long as the President has approved it.

The Secretary shall keep an accurate account of the minutes that were discussed at any Board of Directors meeting. He then has to submit them at the next Board of Directors meeting for discussion by the official board Board of Directors and approval by the President. Upon approval by the majority of the Board of Directors, the minutes shall be adopted, and all policy and procedure in them will continue to be enforced.

#### **Section 2 Waiver of Notice**

Attendance of a Director at any meeting of the Board of Directors will constitute a waiver of notice of such meeting except where such Director attends a meeting for the express purpose of objecting, at the beginning of the meeting, to the transaction of any business because the meeting is not lawfully called or convened.

#### Section 3 Meetings by Remote Communications Technology

Subject to the notice provision aforementioned in this Article, the Directors may also hold meetings by means of a remote electronic communications system, including video or telephone conferencing technology or the Internet, or any combination, only if each person entitled to participate in the meeting consents to the meeting being held by means of that system, and the system provides access to the meeting in a manner or using a method by which each person participating in the meeting can communicate concurrently with each other participant. Participation in such a meeting shall constitute presence in person at such meeting, except participation for the express purpose of objecting to the transaction of any business on the ground that the meeting is not lawfully called or convened.

#### Section 4 Action by Unanimous Written Consent Without Meeting

Any action required or permitted to be taken by the Board of Directors under any provision of law may be taken without a meeting, if all members of the Board of Directors shall individually or collectively consent in writing to such action. Such written consent or consents shall be filed with the minutes of the proceedings of the Board of Directors. Such action by written consent shall have the same force and effect as the unanimous vote of the Directors. Any certificate or other document filed under any provision of law which relates to action so taken shall state that the action was taken by unanimous written consent of the Board of Directors without a meeting and that the Bylaws of this corporation authorize the Directors to so act and such statement shall be prima facie evidence of such authority.

# **Article IX Order**

For the purpose of conducting business, the President shall, in an orderly manner, preside over all of the affairs of the corporation.

# Article X Quorum

A simple majority of the Board of Directors members (including the President) at an official Board of Directors meeting constitutes a quorum.

# **Article XI Ecclesiastical Authority**

This organization is theocratic in government. Any disputes that arise over the interpretation of these bylaws shall be deferred to the highest authority of this ministry. In this case it would be the Board of Elders of McLean Bible Church, with the advice of the Board of Directors. The President shall be responsible for the day-to-day decisions and shall run the affairs of the ministry.

# **Article XII Mutual Interest**

The behavior of anyone in fellowship with this ministry is of common interest to the Board of Directors. (Gal. 6:1) This ministry requires every Board of Directors member to adhere to a life style that is consistent with the doctrines of this ministry as taught in the Holy Scriptures. Therefore, this ministry reserves the right to refuse service to any individual, that is not submitting their life style to this Scriptural mode of conduct. This refusal would include services, benefits and any use of ministry assets.

#### **Article XIII Prohibited Activities**

This ministry is prohibited from engaging in activities which violate its written doctrines. This ministry is also prohibited from condoning, promoting or allowing any of its assets to be used for activities that violate its written doctrines.

#### Article XVI Founder's Vision

To establish an efficient leadership infrastructure, the President shall be responsible to articulate in clear, concise and simple language the vision of the ministry. The purpose of this is to create a consistent and logical framework which empowers staff and volunteers to participate in the decision making processes that reflect the President's heart and vision for the ministry.

# **Article XV Privacy**

This organization shall diligently watch to keep private all records concerning polity, doctrine, counseling and information on individuals in fellowship with this organization. This organization must not disclose any records that may compromise information about a member's attendance, giving and counseling records.

### **Article XVI Finances**

#### **Section 1 Audit**

The Treasurer and or other Board of Directors appointed person shall complete an internal audit. This audit of all financial records shall be made after the close of the calendar year, prior to the end of February.

### Section 2 Checks, Payments and Withdrawals

The Board of Directors of New City Network, Inc. shall adopt a Corporate Expenditures Policy detailing the procedure for properly executing checks, payments and withdrawals.

#### **Section 3 Salaries**

All salaries shall be determined in the following manner:

1. The Board of Directors shall consider each candidate, create a compensation package and vote on the package.

Only uncompensated individuals of the Board of Directors shall vote on any recommended compensation package.

All salaries shall be reviewed each year during the last meeting of the calendar year.

# **Article XVII Property Rights**

All property, real or chattel, shall be taken, held, sold, transferred or conveyed in the corporation's name.

No real or chattel property of the corporation shall be sold, leased, mortgaged, or otherwise alienated without authorization of the President.

The President of the corporation shall certify in such conveyances, leases, or mortgages.

In the event that the corporation ceases to exist, all assets of this ministry shall at the discretion of the Board of Directors be given to organizations that are exempt as described in section 501(c)(3) and/or 170(c)(2) of the Internal Revenue Code of 1986. The receiving organization must be of similar purpose.

### **Article XVIII Other Considerations**

Anything that has not been discussed in this constitution and bylaws shall be discussed and decided upon at an official Board of Directors meeting.

### Article XIX Amendments

Amendments to the Bylaws may be made by a simple majority of the official Board of Directors, including the President.

These bylaws adopted on this day make null and void all prior addenda and these bylaws supersede and replace all previous bylaws voted on prior to this day.
